- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
- (4) Admission to pre- primary stage, should be done in the month of April every year.

- (6) For starting the pre-primary school (Nursery/LKG /UKG etc.) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- (7) Any other conditions that may be imposed in future.
- (8) Government of Karnataka may take action to withdraw this No Objection Certificate in case any of the conditions is violated.
